

NATURE OF POVERTY

Generation after generation, the cycle of poverty traps young women. Given the ineffective social assistance programs and lack of support, it is very difficult for young mothers to simply survive, let alone overcome challenging circumstances. Due to numerous systemic obstacles, many women do not have access to the tools that could help them become self-sufficient.

In the city of St. Louis, the child poverty rate is 39.8%, and the overall poverty

rate is the tenth highest of the counties in the state at 22.8%. Additionally, approximately a third of single mothers in St. Louis live below the poverty line. An overwhelming amount of research shows the negative effects of poverty on children are significant and long-lasting. Children who live in poverty are more likely to experience behavioral/emotional problems, physical health problems, educational abuse, neglect, poor achievements, and developmental

delays. These effects of poverty are worsened by the fact that many lowincome families have limited access to health care and mental health services. Additionally, according to the Brookings Institute, 43% of children whose parents were in the lowest income bracket found themselves there as adults too. To help bridge the gap, Almost Home's Foundations to Success Transitional Living Program allows young mothers to build a solid foundation where they can access safe and stable housing, accomplish educational and vocational goals, and receive parenting support, therapeutic counseling, and independent living classes. This support helps them become confident young women who are empowered to achieve financial stability for their families.

ALMOST HOME'S PROGRAMS ARE A PROVEN PATHWAY OUT OF POVERTY.

Since 1993, Almost Home has guided **1,700 young mothers** (*and counting!*) on their journey to create a better future for themselves and their children. In the past year, we were able to serve 75 mothers.

THE ALMOST CONTINUUM OF CARE

Through our Foundations to Success Transitional Living Program at Almost Home, young moms learn how to improve their lives and the lives of their children. They are empowered to take advantage of the opportunities that we offer to help them overcome obstacles and truly succeed.

FOUNDATIONS TO SUCCESS (FTS)

Building a successful future starts with a solid foundation. FTS provides a safe, nurturing environment to 16-21 year-old, low-income, single moms and their children. We equip them to pursue and achieve their education and career goals by providing: immediate needs housing, food, clothing, baby supplies, case management, counseling and other services.

ALUMNI SUPPORT PROGRAM (ASP)

Former FTS Program participants have access to on-going stabilization support, coaching, support groups, therapy, and referrals to community resources through the ASP Program. Access to these services for up to eight years helps young moms achieve greater economic self-sufficiency.

ALMOST HOME APARTMENTS

Located across the street from our transitional living facility, our apartments are rent subsidized and in close proximity to Almost Home. This allows FTS Alumni to live independently while still easily accessing support services.

Almost Home is synonymous with safety. That was especially so in 2020, a hard year for everyone. But Almost Home continued to provide a safe and supportive environment for our moms and their children.
